## SECTION 4: First aid measures

### 4.1. Description of first aid measures

#### General information

In the case of accident: Contact a doctor or casualty department – take the label or this safety data sheet.

If the person is conscious, rinse the mouth with water and stay with the person. Never give the person anything to drink.

In case of malaise, seek medical advice immediately and bring the safety data sheet or label from the product. Do not induce vomiting, unless recommended by the doctor. Have the person lean forward with head down to avoid inhalation of or choking on vomited material.

#### 4.2. Most important symptoms and effects, both acute and delayed

Workers using cement may develop an allergy to chromium, with symptoms ranging from a mild rash to severe skin ulcers. In addition to skin reactions, hexavalent chromium can cause occupational asthma. Symptoms include wheezing and difficulty breathing. Workers may develop both skin and respiratory allergies to hexavalent chromium. Sensitisation: This product contains substances, which may trigger allergic reaction upon dermal contact. Manifestation of allergic reactions typically takes place within 12-72 hours after exposure.

#### 4.3. Indication of any immediate medical attention and special treatment needed
